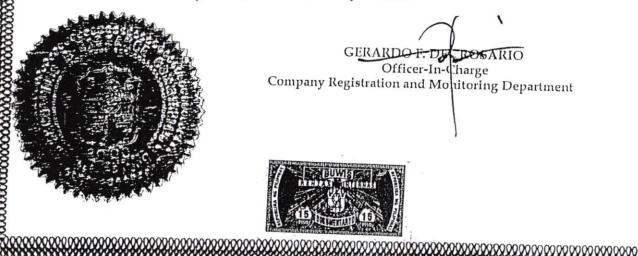

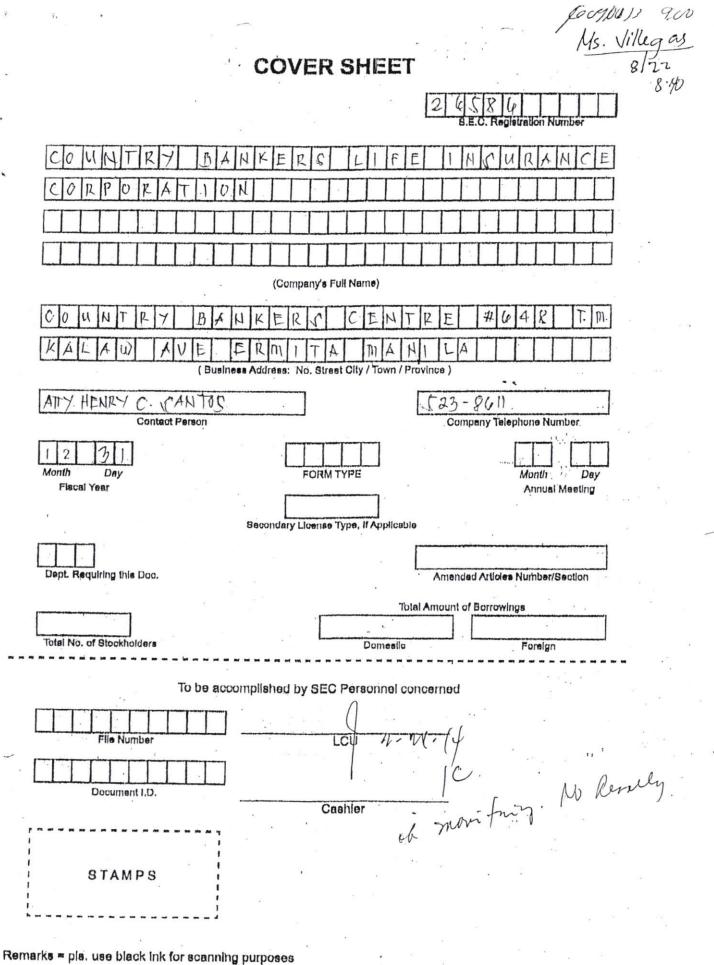
COUNTRY BANKERS LIFE INSURANCE CORPORATION [Amending Article IV by extending the term of its existence.]

copy annexed, adopted on April 25, 2013 by a majority vote of the Board of Directors and by the vote of the stockholders owning or representing at least two-thirds of the outstanding capital stock, and certified under oath by the Secretary and a majority of the Board of Directors of the corporation was approved by the Commission on this date pursuant to the provision of Section 16 of the Corporation Code of the Philippines, Batas Pambansa Blg. 68, approved on May 1, 1980 and copies thereof are filed with the Commission.

Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing company and time shares/club shares/membership certificates issuers or selling agents thereof. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

AMENDED ARTICLES OF INCORPORATION OF THE

"COUNTRY BANKERS LIFE INSURANCE CORPORATION" (Formerly: COUNTRY LIFE INSURANCE CORPORATION)

KNOW ALL MEN BY THESE PRESENTS:

That we, all of whom are of legal age, and residents of the Philippines, on this day have voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the Philippines:

AND WE HEREBY CERTIFY:

FIRST ~ That the name of said corporation shall be:

"COUNTRY BANKERS LIFE INSURANCE CORPORATION"

SECOND ~ That the purposes for which said corporation is formed are:

To carry on the business of life and health insurance, and in particular, to grant or effect assurance of all kinds, for the payment of money, by way of immediate or deferred annuities upon the death of a person, or on his surviving a specified period, or otherwise contingently on the continuance or cessation of life, including contracts or pledges for the payments of endowments or annuities, insurance against personal injuries by accident either in connection with life policies, or otherwise and the business of insurance against loss of health or incapacity from physical causes of any description either alone or in combination Page 2..... with life insurance, to re-insure all or any of the risks of the Corporation and to undertake any authorized risks by way of re-insurance and act as life insurance agency for other insurance company or companies and other insurance and other businesses permitted to be conducted by a life insurance company.

IN FURTHERANCE OF THE ABOVE PURPOSES, the corporation shall have the power -

- a) To extend loan to its policy holders on such terms and conditions under the insurance policy provisions and subject to the requirements of the laws;
- b) To acquire by purchase, lease or otherwise, lands and interest therein, and to own, hold, improve, develop and manage real estate so acquired, and to erect or construct thereon such housing projects, buildings or other structures as the corporation may deem necessary for the furtherance of its business; to rebuild, enlarge, alter or improve any buildings or other structures which may now or hereafter be erected or constructed on any lands so owned, held or occupied by the corporation, and to mortgage, sell, lease, or otherwise dispose of any lands or interest in lands and in buildings or structures owned by or belonging to the corporation;
- c) To purchase or otherwise acquire and undertake all or any part of the business, property and liabilities or any person or company carrying on any business which this corporation is authorized to carry on or

possessed of property suitable for the purpose of this corporation;

- d) To promote any other company for the purpose of acquiring all or any of the property and liabilities of this Company or of advancing directly or indirectly, the objects or interest thereof, and to take or otherwise acquire the payment of any debentures or other securities issued by any such company;
- e) To take or otherwise acquire and hold shares in any other company having objects altogether or in part similar to those of this corporation or carrying on any business capable of being conducted so as directly or indirectly to benefit this corporation;
- f) To enter into any arrangement for sharing profits, union of interest, cooperation, joint adventure, reciprocal concession or otherwise, with any person or company carrying on or engaged in or about to carry on or engaged in any business or transaction which this corporation is authorized to carry on, or any business or transaction capable of being conducted so as directly or indirectly to benefit this corporation, and to take, or otherwise acquire shares and securities of any such company and to sell, hold, re-issue, with or without guaranty or otherwise deal with same;
- g) To sell the undertaking of the corporation or any part thereof for such consideration as the corporation may think fit, and in particular for shares, debentures or securities of any other company having objects altogether or in part similar to those of this corporation;

h) To amalgamate with any or other company having objects altogether or in part similar to those of this corporation;

WO EXCHANGE

- To distribute any of the property of the corporation among members specie, but that no distribution amounting to reduction or capital be made without the sanction of law;
- j) To make, accept, endorse and execute promissory notes, bills of exchange and other negotiable instruments and to guarantee the performance of contracts by members of or persons having dealings with the corporation;
- k) To do all or any of the above things in any place in which the corporation may determine, as principals, agents, contractors, trustees, or otherwise, alone or in conjunction with others, and to do all such other things as are incidental or conducive to the attainment of the above subject;
- To do and perform any and all acts and things to exercise all of the general powers conferred by law upon corporations similarly organized and usually and ordinarily incidental to companies of like nature and kind;
