- Since the implementation will eventually happen, Dir. ACruz also suggested that he might as well be removed as one of the company signatories to the bank accounts;
- The Chairwoman asked him if he can recommend somebody who can replace him as the company's CorSec. Dir. ACruz stated that he has a recommendee and will submit her biodata for the consideration of the board;
- In the interim, the Chairwoman asked Dir. ACruz to still serve as the CorSec. Dir. ACruz suggested that the matter be referred to the Board for their approval;
- The ExCom decided to give all the members of the Board the opportunity to submit names for the Corporate Secretary until April 2023 in time for the next Stockholders' Meeting;
- Meanwhile, the qualifications of a Corporate Secretary will be prepared for the guidance of all Directors. The said matter will be presented at the next board meeting and all recommendations will be directed to the GovCom;
