- After a lengthy discussion by the GovCom, they have decided to recommend to the Board the following options, to wit:
 - To offer the CorSec position to Atty. Nelson Manalili, AVP-Legal of CBIC with a monthly allowance of P20K (P10K from CBLIC and P10K from CBIC). No per diem will be given to him in attending all the committee meetings. The total allowance he will be receiving annually will amount to P240K (P120K from CBLIC and P120K from CBIC). While this option will be the most cost efficient for the company, this is still subject to the acceptance by Atty. Manalili;

- To give the CorSec a monthly remuneration of P40K net of taxes (P20K from CBLIC and P20K from CBIC). No per diem will be given to him/her in attending all the committee meetings. The total annual net compensation he/she will be receiving will amount to P480K (P240K from CBLIC and P240K from CBIC);
- 3. To give the CorSec a monthly remuneration of P30K net of taxes (P15K from CBLIC and P15K from CBIC). In addition to that, the CorSec will be receiving P6K per diems net of taxes (P3K from CBLIC and P3K from CBIC) in all the committee meetings that he/she will be attending, to wit:
 - 1. Monthly Board Meetings or Twelve (12) Meetings Annually;
 - 2. Monthly ExCom Meetings or Twelve (12) Meetings Annually;
 - 3. Quarterly AuditCom Meetings or Four (4) Meetings Annually;
 - 4. Semi-Annually GovCom Meetings or Two (2) Meetings Annually or as the need arises;

The total annual net compensation he/she will be receiving is estimated to be P540K (P270K from CBLIC and P270K from CBIC);
